



# License Plan Descriptions for Unisys Stealth Software Products

## License Term

Each Unisys Stealth software product license begins

- Upon Unisys shipment of the Stealth software product on computer readable media; or
- When Unisys makes the software available for download or use.

Unless the License Term ends earlier according to the agreement under which the applicable license was granted, the License Term is limited to the license period in the order for the software or the license period in the Unisys Stealth software product style/description; the License Term is 60 months if there is no license period in the order or there is no license period in the Unisys Stealth software product style/description.

## Extended Term Plan (ETP)

An **Extended Term Plan** license is a license to use a Stealth software product for an extended term of 12 to 84 months, as Client and Unisys may agree in an order accepted by Unisys. Unisys charges a single fee for the Extended Term Plan license. Upon expiration of the Extended Term Plan license, the license will continue on a month -to-month basis at the Unisys then-current monthly license charge until Client or Unisys ends the license according to its terms or Client and Unisys replace the license with another license.

## Fixed Term Plan (FTP)

A **Fixed Term Plan** license is a license to use a Stealth software product for a fixed term of 12 to 84 months, as Client and Unisys may agree in an order accepted by Unisys. Unisys charges a single fee for the Fixed Term Plan license. Upon expiration of the Fixed Term Plan license, the license ends; Client and Unisys may agree to replace the expired license with another license.

## Stealth(aware) Software License

The license for the Stealth(aware) software product is limited to one executing copy for a single client datacenter. Stealth(aware) discovery agent software may be deployed by Client on an unlimited number of endpoints.

## Stealth Client Driver Software License

The license for the Stealth Client Driver software product is limited to the authorized number of **Concurrent Users** (as defined below) listed on the order accepted by Unisys.

“**Concurrent User**” means a user that may initiate or run the Stealth client driver software on an end user personal computing device or virtual machine, at the same moment in time as another user may initiate or run the Stealth client driver software on an end user personal computing device or virtual machine; each user is a **Concurrent User**. Client and Unisys must list the number of authorized **Concurrent Users** in the order accepted by Unisys. Each single user initiating the Stealth client driver software (whether because the Stealth Client driver software is configured to initiate “on demand” or configured to be “always on”) consumes one count of the authorized number of **Concurrent Users**.

## Stealth Server Software License

The license for the Stealth Server software is limited to installation and use on the authorized number of servers and virtual machines, (running supported operating systems), listed on the order accepted by Unisys.

## Stealth for Mobile Software License

The license for the Stealth for Mobile software product is limited to the authorized number of **Users** (as defined below) listed on the order accepted by Unisys. “**Users**” means the number of all named users identified in the Stealth for Mobile licensing user group established by Client.

## Stealth Secure Virtual Gateway Software

- **# IP Address Software Licenses**

These licenses for the Stealth Secure Virtual Gateway software are limited to assignment and use with the authorized number of IP addresses on clear-text devices (whether server or non-server) listed on the order accepted by Unisys. Each IP address consumes one license. This license type is available for Stealth Secure Virtual Gateway Software version 5.0 and later and for Stealth Secure Virtual Gateway Software version 3.4 and earlier.

- **Per Gateway Software License**

Each licensed copy of the Stealth Secure Virtual Gateway software may be used with only one gateway. This license type is available for Stealth Secure Virtual Gateway Software version 4.0 and later.

**Stealth Secure Virtual Gateway Software License**

Each licensed copy of the Stealth Secure Virtual Gateway software may be used with only one gateway. This license type applies to the Stealth Secure Virtual Gateway software version 4.0 and later.

**Stealth Secure Virtual Gateway Device Software License**

The license for the Stealth Secure Virtual Gateway software is limited to assignment and use with the authorized number of IP addresses on clear-text devices (whether server or non-server) listed on the order accepted by Unisys. Each IP address consumes one license. This license type applies to Stealth Secure Virtual Gateway software version 3.4 and earlier.

**The Guide**

Unisys provides information on supported operating systems and required software in the *Unisys Stealth Planning, Installation, and Administration Guide* or the *Unisys Stealth Information Center* for the version of the software product license received (the “**Guide**”). Unisys publishes the Guide at <http://www.support.unisys.com> or at another web site designated by Unisys. A Client may not have access to the Guide if the Client acquired the software product license from a Unisys reseller and Client contracted for support services from the reseller; in these circumstances, Client should request information about supported operating systems from the Unisys reseller.
